


ANTILOGIC



ANTILOGIC System (ANTILOGIC) - a new product on the market of technical means to ensure the confidentiality of meetings and business negotiations.

Is a mini-conference system with built-in privacy of meetings up to 64 participants. It is used absolutely safe for health method of acoustic countermeasures.

At the same time, the system provides a high comfort of the negotiations (the minimum audibility of acoustic noise) and high-quality speech communication to all participants.

ANTILOGIC can operate in two modes:

Mode 1 "CONFERENCE SYSTEM" - provides amplification and main functions of an ordinary conference system.

Mode 2 "CONFIDENTIAL MEETING" - the confidentiality of the meeting, made by t.e.akusticheskim "destruction" of the semantic intelligibility of all participants in the entire volume of the space for possible unauthorized retransmission by any means or recording acoustic control.

Virtually eliminated and legible record and relay

by means of acoustic monitoring of the participants!

Private conversation can be conducted with any volume!

The system is easy for a few minutes, installed by untrained personnel, and when you first start itself automatically adapts to the acoustic properties of the meeting room or conference room, these settings are saved in the future.

Provided for offline power from its own built-in rechargeable battery.

You also have the opportunity to conduct an authorized recording of speech of participants in all modes.

It is possible to integrate with existing videoconferencing systems and promising.

ADVOCATE- 4 - figuratively speaking - "electronic" room "for private talks and meetings" - designed for efficient operation of an acoustic anti-acoustic control of all types throughout the volume of typical office space in the cabin cars during the confidential negotiations and meetings.

The device has a full set of unique small size and weight, and transferred in a small carrying case, agreed with the customer.

Can be used in standalone mode (battery power supply 10 hours-work-wait 7 days) and in a steady uninterrupted operation (powered by a 220V battery charging with automatic).

Due to the accurate selection of acoustic noise and the creation of spatially separated (eg, within the negotiating table), the sound of "barriers" ADVOCATE-4 without the use of a special intercom (headsets with microphones) can effectively deal with a record of progress meetings by the participants of meetings with the most modern digital voice recorders (mono and stereo) without making any discomfort in the course of the meeting!

Product "ADVOCATE-3 COMFORT" is designed to effectively counteract the work of the acoustic control of all types throughout the volume of typical office space in the cabin cars during confidential talks and meetings.

The device is moved to the folder for the elite market.

The principle of recording or transmission of the speech signal in a particular acoustic means of control is irrelevant.

Acoustic noise emitted in the speech range of two miniature speakers, which take the noise signal over the air.

Uses acoustic countermeasures for "destruction" of the speech signal unauthorized entry or retransmission by any means of acoustic monitoring.




The device masks the real speech signal using a special acoustic noise. It is also used false acoustic signals - transmission FM radio stations.

PSP-2AM AUTO **(Pocket Speech Protector Acoustic 2 AUTO)**

SPHERE

SPHERE - a desktop transparent acoustic "box" for multiple (up to 5-7) mobile phones and smartphones.

Works practically silent 10 days continuously in standalone mode.



During the private talks included members spread their cell phones next to each other on the table. The head includes a device and "covers" them to the zone in which mobile phones are available

In this acoustic noise is securely destroys the intelligibility of a possible retransmission or recording.

Due to the acoustic barrier - transparent hemisphere (SPHERE) with a rubber seal, this interference is the instrument has a very low level and does not distract the negotiators.

At the same time, the call signal from the mobile phone is almost unchanged!

Thus, the negotiators did not miss an important call with the full guarantees of security used by mobile devices!
